The Governments of Liberia, Côte d'Ivoire, Sierra Leone and Guinea have received funding from the African Development Bank, the World Bank, the European Investment Bank and KfW, and also bring the Capital to contribute to the financing of the CLSG Interconnection Project. According to the Financing Arrangements, Governments have lent these funds to CLSG TRANSCO in order to implement the said project. TRANSCO CLSG intends to use part of these funds for the recruitment of an Individual Consultant to provide a TRAINING IN HEALTH, SAFETY & ENVIRONMENTAL MANAGEMENT IN PROJECTS AND PROGRAMS FOR CLSG COUNTRIES' ENVIRONMENTAL AGENCIES AND UTILITIES.

Consistent with the overall objectives of TRANSCO CLSG, the Consultant (Individual Consultant) will perform a training of the CLSG Environmental Agencies and National Utilities on the preparation, the approval, the implementation and the Monitoring of the Health, Safety, and Environmental Management in a Project and a Program.

The duration of the assignment is estimated at 30 days for the whole assignment.

The services to be provided shall include but not necessarily be limited to the following:

Enable participants to achieve the following specifics objectives:

- Acquiring the necessary skills for the preparation, the approval, and the implementation of the ESIA, ESMP and ESMP Construction for a Project or Program,
- Acquiring the necessary skills for the Management and the Monitoring of the Environmental Component during the implementation of a Project or a Program.
- Acquiring the necessary skills for the Management and the Monitoring of the Hygiene, Health, Safety Components during the implementation of a Project or a Program,
- Development and improvement of knowledge of International and Donors Environmental Policies, Procedures and standards (World Bank, AfDB, KfW and EIB).

- Acquiring the necessary skills for the Management and the Monitoring of the Hygiene, Health, Safety and Environmental Component during the implementation of a Transmission line Project or Program.

To do so, the Consultant shall carry out the following tasks:

- Conduct a quick training needs assessment of the CLSG Countries Environmental Agencies and Utilities in coordination with TRANSCO CLSG;
- Propose the training methodological approach and the training relevant topics;
- Design the training material and take care of the logistics including secretariat, room rental, coffee break, lunch and participants per diems;
- Provide training for target groups in the four CLSG countries in coordination with TRANSCO CLSG;
- Assess the training and prepare a completion report which will include some recommendations for follow up or other trainings, etc.

TRANSCO CLSG now invites eligible Consulting Firms (Individual Consultants) to indicate their interest in providing the services described above. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services, including CVs, description of similar assignments, experience in similar conditions, etc.

The requirements are:

The Consultant should have at least the following qualifications and experience:

- Hold at least a Master Degree in the field of Environmental Sciences;
- 10 years' post qualification experience in preparation, approval, implementation and monitoring of the Hygiene, Health, Safety and Environmental Components of a Project or Program;
- Have completed at least five (5) similar assignments;
- Experience within the power sector and the International and Donors Environmental Policies, Procedures and Standards (World Bank, AfDB, KfW, EIB) would be an advantage.
- Be Bilingual (French & English) as the training will take place in 2 French and 2 English speaking countries.
