According to the Financing Arrangements, Governments have lent these funds to CLSG TRANSCO in order to implement the said project. TRANSCO CLSG intends to use part of these funds for the recruitment of a National Individual Consultant for training of the Liberian Environmental Protection Agency and National Utilities on the preparation, the approval, the implementation and the Monitoring of the Health, Safety, and Environmental Management in a Project and a Program.

The Objective of the Assignment is to train the Sierra Leonean Environmental Protection Agency and National Utilities on the preparation, the approval, the implementation and the Monitoring of the Health, Safety, and Environmental Management in a Project and a Program.

The training aims to enable participants to achieve the following objectives:

- To acquire the necessary skills for the preparation, the approval, and the implementation of the ESIA, ESMP and ESMP Construction for a Project or Program,
- To acquire the necessary skills for the Management and the Monitoring of the Environmental Component during the implementation of a Project or a Program.
- To acquire the necessary skills for the Management and the Monitoring of the Hygiene, Health, Safety Components during the implementation of a Project or a Program,

- To develop and improve knowledge of International and Donors Environmental Policies, Procedures and standards (WB, AfDB, KfW and EIB).
- To acquire the necessary skills for the Management and the Monitoring of the Hygiene, Health, Safety and Environmental Component during the implementation of a Transmission line Project or Program.

TRANSCO CLSG now invites eligible consultants to indicate their interest in providing the services described above. Interested consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services through the documentation, references to similar services, experience in similar assignments, availability, etc.

The eligibility criteria, the establishment of the shortlist and the selection process will be consistent with the consultant selection method as described in the "Public Procurement Regulation of Sierra Leone".

The Consultant should have at least the following qualifications and experience:

- Hold at least a Master Degree in the field of Environmental Sciences;
- 10 years' post qualification experience in the preparation, the approval, the implementation and the monitoring of the Hygiene, Health, Safety and Environmental Components of a Project or Program;
- Have completed at least five (5) similar missions;
- Experience within the power sector and the International and Donors Environmental Policies, Procedures and Standards (World Bank, AfDB, KfW, EIB) would be an advantage.
