CONSIDERING the Resolution TRANSCO CLSG/S.HOLDERS/3/ RES.27/08/13 of the first Shareholders' Meeting of TRANSCO CLSG held in Monrovia on August 27, 2013 appointing the Chairperson of the Board of Directors of TRANSCO CLSG;

CONSIDERING the Resolution TRANSCO CLSG/BOARD/5/RES.7/11/13 of the second meeting of the Board of Directors held in Abidjan on November 7, 2013, authorizing the Chairperson of the Board to execute the International Project Agreement relating to the CLSG Interconnection Line;
